## MEMBERSHIP CRITERIA

**Professional Member** is only available to a person who:

- (a) is a financial member and
- (b) has achieved a Certificate in Reflexology or Diploma at a Registered Training Organisation (RTO), note correspondence courses are not accepted by RAoA
- (c) has a current reflexology qualification i.e. completed within the last 5 years
- (d) has current and maintains a minimum of one million dollars Professional Indemnity and one million dollars Public Liability Insurance Policy
- (e) has current and maintains a Senior First Aid Certificate or equivalent, and
- (f) is committed to on-going participation in RAoA's Continuing Professional Training (CPT) Program.

**Intermediate Member** is only available to a person who:-

- (a) is a financial member; and
- (b) has achieved a Certificate in Reflexology or Diploma at a Registered Training Organisation (RTO), or has applied for and been assessed as competent under RPL

Please Note: Diplomas HLT51707, HLT51712 and HLT52515 are currently accepted for provider status by all Health Funds that cover reflexology. Not all reflexology qualifications are granted provider status, please check with the RAoA Membership Officer for clarification.
